Dear Tribal Leader:

On February 9, 2018, the President signed into law Public Law 115-123 which included the Family First Prevention Services Act. This law made significant changes to federal child welfare programs authorized in titles IV-B and IV-E of the Social Security Act. One important change is the creation of a new optional program that will allow states and tribes operating the title IV-E program to use federal title IV-E funds to provide time-limited mental health and substance abuse treatment services and in-home parent skill-based programs to certain children, youth and families to prevent children from entering foster care.

The law authorizing this new funding also has requirements relating to research-based evidence standards that prevention services must meet, as well as numerous provisions relating to evaluation, performance standards and reporting requirements that title IV-E agencies will need to meet. However, the law also recognizes that tribes operating the title IV-E program may require greater flexibility to provide services and programs that are adapted to the culture and context of the tribal communities served.

The Children's Bureau within the Administration for Children and Families (ACF) is committed to providing tribes with maximum flexibility in implementing the program, consistent with the requirements of the law, and we seek the input of Tribal Leaders prior to developing implementing guidance. Therefore, we are requesting tribal consultation relating to the implementation of the new Title IV-E Prevention Services Program. This letter provides information on consultation that will be conducted by teleconference in August. ACF will also hold an in-person tribal consultation on September 13, 2018 that will provide an opportunity to consult on the Title IV-E Prevention Services Program, as well as issues affecting other ACF programs. Information on the September consultation will be provided separately.

To prepare for consultation, the Children's Bureau is offering a briefing webinar for Tribal Leaders and/or members of your staff. The briefing webinar will be an opportunity to learn more about the Title IV-E Prevention Services Program and to consider areas in which tribes may require additional flexibility to ensure effective implementation in tribal communities. Participation in this briefing may assist you and your staff by providing information and context that will allow for a more meaningful exchange during tribal consultation.

Both tribal consultation teleconference calls are open to all Tribal Leaders or their designees and may address any aspect of the implementation of the Title IV-E Prevention Services Program and areas where you believe that tribes may require flexibility, consistent with the requirements of the law.
