
SOCIAL MEDIA CAMPAIGN TOOLKIT INTRO

ABOUT THE INDIAN CHILD WELFARE ACT

The Indian Child Welfare Act (ICWA) is a long-standing federal law protecting the well-being of Native children by upholding family integrity and stability within their community. Opposing ICWA ignores the long-standing government-to-government relationship between tribal nations and the federal government. Tribal nations, tribal organizations, and non-tribal partners are taking action to protect ICWA and end the threat of forced removal of Native children from their families, tribes, and communities.
