
CHOCTAW NATION OF OKLAHOMA FACT SHEET FOR KINSHIP/GRANDFAMILIES

This fact sheet includes national data and information on Choctaw Nation of Oklahoma tribal-specific programs that can assist kinship/grandfamilies. GrandFacts fact sheets for each state and the District of Columbia are also available <u>online</u>.

American Indian and Alaska Native Children Disproportionately Live in Grandfamilies

While the overrepresentation of American Indian and Alaska Native (AI/AN) children in kinship/grandfamilies is likely a product of the centuries-long shameful treatment of this community by the United States and the many inequities this community continues to face, it is also a reflection of their cultural strengths and resilience. Choctaw Nation places around one-third of children in tribal foster care with relative/kinship families. Choctaw Nation actively and continuously searches for family during all stages that a child is in tribal custody.

Kinship definitions as described in Choctaw Nation Child and Family Services Policy:

Kinship placement: Out-of-home placement by a relative, stepparent, or other responsible adult who has a bond or tie with the child, or a family relationship role with the child's parent(s) or the child, prior to the child's entry into foster care.

Relative kinship home: Foster home in which the individual or family is related to the child(ren) through marriage and/or blood relationship.

Non-relative kinship home: Foster home in which the individual or family has a bond or tie with the child(ren) or child(ren)'s parents prior to the child(ren)'s entry into foster care.

Choctaw Nation service area: The Choctaw Nation service area consists of 10¹/₂ counties within the Choctaw Nation reservation boundaries: McCurtain, Le Flore, Haskell, Latimer, Pushmataha, Choctaw, Bryan, Atoka, Pittsburg, Coal, and Hughes (half). The Choctaw Nation also serves families residing off-reservation who are licensed tribal foster homes.

Description: The Helping Grandparents Raising Grandchildren program under the Choctaw Health Services Department offers support to grandparents and relative caregivers who are raising their relative children.

The program offers respite care, transportation assistance, gardening supplies, clothing, day trips to museums or camps, school events, fishing supplies, legal services, daycare, and much more.

Kinship programming is funded through a mix of federal and tribal funds.

For those families that do not qualify for the Grandparents Raising Grandchildren program described above, Choctaw Nation offers many different opportunities and programs that may benefit Choctaw kinship families.
