
## Salt River Pima-Maricopa Indian Community

This fact sheet includes local and national data and information on Salt River Pima-Maricopa Indian Community (SRPMIC) programs that can assist kinship/grandfamilies. GrandFacts fact sheets for each state and the District of Columbia are also available online.

# American Indian and Alaska Native Children Disproportionately Live in Grandfamilies

While the overrepresentation of American Indian and Alaska Native (AI/AN) children in kinship/grandfamilies is likely a product of the centuries-long shameful treatment of this community by the United States and the many inequities this community continues to face, it is also a reflection of their cultural strengths and resilience. SRPMIC places around one-third of children in tribal foster care in relative/kinship homes. In 2023, of the 122 children in tribal foster care, 36 children were placed in relative/kinship homes.

# Salt River Pima-Maricopa Indian Community (SRPMIC) Programs That May Help

The Salt River Pima-Maricopa Indian Community is situated in Maricopa County, part of the metropolitan Phoenix area, and shares common boundaries with the cities of Mesa, Tempe, Scottsdale, Fountain Hills, and the Fort McDowell Yavapai Nation. SRPMIC is a sovereign tribe that operates a full-service government and oversees several departments, programs, projects, and facilities that serve the community. The community is comprised of two Native American tribes: the Pima, "Akimel O'Odham" (River People), and the Maricopa, "Xalychidom Piipaash" (People who live toward the water).

The SRPMIC defines its service area as the area within the boundaries of the Salt River Pima-Maricopa Indian Community. The programs and services listed in this fact sheet are available to SRPMIC citizens and kinship families that meet the eligibility criteria described in the entries for each program and service. Some resources are available to other tribal members or community members, as noted in the eligibility criteria listed along with each program and service. Services can be accessed by contacting the appropriate department. The SRPMIC <a href="Phone Directory">Phone Directory</a> contains phone numbers for governmental resources, as well as some private businesses.

SRPMIC kinship care definition: The care and supervision of a foster child in a foster home provided by a relative or individual who has a significant relationship with the child. Kinship care also includes relatives caring for children who are not in the custody of Social Services.
