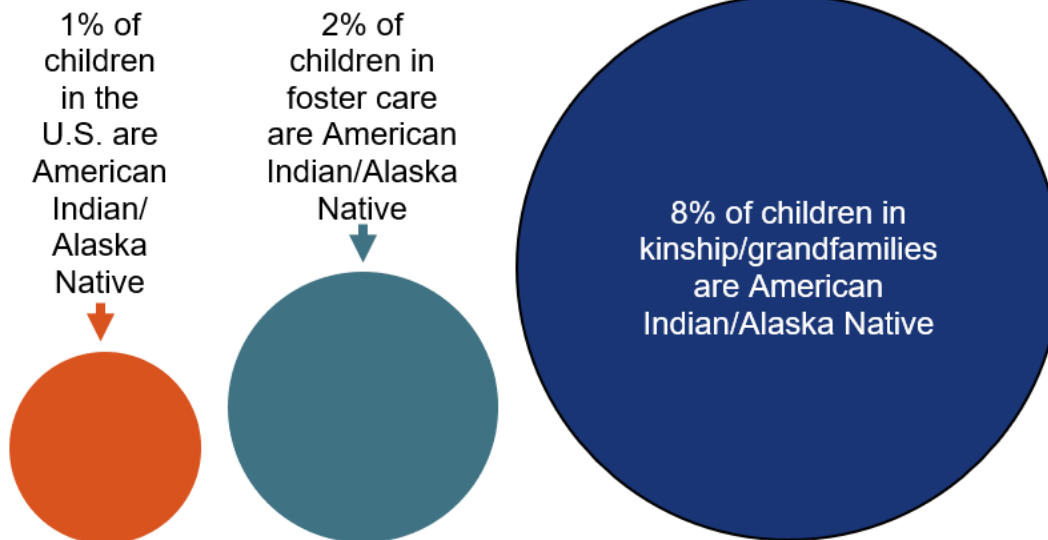
Confederated Tribes of Grand Ronde

American Indian and Alaska Native Children Disproportionately Live in Grandfamilies

While the overrepresentation of American Indian and Alaska Native (AI/AN) children in kinship/grandfamilies is likely a product of the centuries-long shameful treatment of this community by the United States and the many inequities this community continues to face, it is also a reflection of their cultural strengths and resilience. As of February 2024, of the 188 Indian Child Welfare Act protected children in Oregon Department of Human Services custody, 29.8% (56 children) were placed in relative foster family homes.

Confederated Tribes of Grand Ronde Programs That May Help

The Confederated Tribes of Grand Ronde (CTGR) includes over 30 tribes and bands from western Oregon, northern California, and southwest Washington. Tribal bands include the Kalapuya, Molalla, Shasta, Umpqua, Rogue River, Chinook, and Tillamook. The CTGR Reservation spans 11,500 acres in Yamhill County, Oregon. CTGR has 5,400 enrolled members and is governed by a nine-member Tribal Council elected by the Tribe's voting membership. CTGR offers its members an array of services and programming, including social services, housing, education, health and wellness, economic development, natural resources, cultural services, and more.

The CTGR has a six-county service area in Oregon covering Marion, Multnomah, Polk, Tillamook, Yamhill, and Washington Counties. The programs and services listed in this fact sheet are available to CTGR enrolled members and relative families that meet the eligibility criteria described in the entries for each program and service. Some resources are available to enrolled members of other tribal nations and community members, as noted in the service area and eligibility criteria listed along with each program and service.

Relative definitions as outlined in the CTGR Children and Families Ordinance

CTGR definition of relative: Any person who is related to the child by blood or marriage, or any person who has established a Significant Familial-Type Relationship to the child ([Chapter 301 Part 1, \(e\)\(23\)](#)).

Significant Familial-Type Relation is a long-term and ongoing personal relationship with the child in which an individual ([Chapter 301 Part 1, \(e\)\(24\)](#)):

- a) Has or had physical custody of the child or resided in the same household as the child;
- b) Supplied, or otherwise made available to the child, food, clothing, shelter, and incidental necessities and provided the child with necessary care, education, and discipline; and
- c) Through interaction, companionship, interplay, and mutuality helped fulfill the child's psychological needs for a parent as well as the child's physical needs.

Description: The CTGR Youth Empowerment & Prevention program is committed to promoting a healthy lifestyle and providing prevention, education, training, and advocacy to strengthen youth, families, and community based on cultural values, tradition, and beliefs. Among other youth, family, and community support and prevention activities, some services offered include community information for alcohol, drug, tobacco, and suicide prevention; cultural activities for youth and families; recreational activities for youth and families; a culturally relevant teen pregnancy prevention curriculum, education, and activities; youth and parent training; 1-on-1 case management; transitional services; court advocacy; and equine therapy.

Service area: CFS serves enrolled tribal members when there is a legal case, whether in or out of state. The prevention program under CFS serves families where there is an enrolled tribal member in the home in Grand Ronde and surrounding counties. If outside of the Grand Ronde area, staff will try to connect families to local services.

Eligibility & Description: The CFS Program offers a variety of support services to parents, children, and foster families to ensure child safety and preserve family structure. The program provides support for parenting, housing, mental health, substance abuse, and transportation. CFS Program areas include intake and referral, case management, investigation, foster

care, and prevention. The CFS Program investigates reports of child abuse, neglect, and abandonment and works toward the goal of prevention, family reunification, and permanency for children. CFS also recruits and certifies foster homes. The Foster Care Program offers 1-on-1 support for foster parents, specialized training, cultural support, foster care support payments, child care reimbursement, respite care, and more.

Eligibility: Open to people in the service area who are actively looking for employment or engaged in full-time training and/or education; have attempted to access alternate resources; have recently been employed (in the last 45 days); suffer from a temporary and/or chronic medical condition and are seeking Social Security; are temporarily unemployed; or are medically unable to look for work on a short-term basis

Description: Employment-related assistance designed to help tribal members find and maintain employment. Services include case planning to address barriers to employment and assistance with work clothing, tools, transportation, and job-related licensing and fees.

- Eligibility:** Enrolled tribal members who are seeking employment and reside within the seven-county service area. Eligibility for services requires a diagnosed physical, mental, emotional, or learning disability that is documented by a professional and is shown to be a barrier to employment.
- Description:** Vocational Rehabilitation (VR) provides culturally relevant services to help CTGR tribal members with disabilities to maintain or regain employment. Services include assistance with career exploration, job searches, work clothing and tools, transportation, licensing and fees, and on-the-job training. VR is also a youth-serving program, particularly for youth 14 years of age or older who have an Individualized Education Plan (IEP), a plan or program that allows youth to receive educational services tailored to their needs.

Description: Offers up to \$3,500 in grant funds for homeowners in need of basic energy-related repairs to their primary residence
