
THE ONEIDA NATION FACT SHEET FOR KINSHIP/GRANDFAMILIES

This fact sheet includes national data and information on the Oneida Nation's tribalspecific programs that can assist kinship/grandfamilies. Oneida Nation refers to the adults in these families as relative caregivers. GrandFacts fact sheets for each state and the District of Columbia are also available <u>online</u>.

American Indian and Alaska Native Children Disproportionately Live in Grandfamilies

While the overrepresentation of American Indian and Alaska Native (AI/AN) children in kinship/grandfamilies is likely a product of the centuries-long shameful treatment of this community by the United States and the many inequities this community continues to face, it is also a reflection of their cultural strengths and resilience. The Oneida Nation is currently serving 30 relative/kin families and 64 children. Of the children in out-of-home placements, 62% reside in the home of a relative caregiver. The Oneida Nation anticipates the number of children placed with relative caregivers to increase at least 50% with the enactment of <u>Wisconsin Act 119</u>, which expanded the definition of "relative" and added the term "like-kin" to support relative caregivers.

The Oneida Nation is a federally recognized tribe in Wisconsin. There are currently 17,000 enrolled members worldwide, and the Oneida Nation's modern-day lands are in Brown and Outagamie Counties. The Oneida Nation offers an array of thriving programs for its citizens and surrounding communities. Services and programming encompass family services and comprehensive health, housing, culture and recreation, education and career development, justice, and economic support services, among other offerings. The Oneida Nation's modern-day lands and service are comprised of Brown and Outagamie Counties. However, many of Oneida Nation's programs serve Oneida citizens throughout the State of Wisconsin and nationwide. Some resources are available to other tribal members or community members, as noted in the eligibility criteria listed along with each program. Services can be accessed by contacting the appropriate program department.

Oneida Nation relative and kinship definitions from the Oneida Code of Laws:

Extended Family: a person who has reached the age of eighteen (18) and who is the child's grandparent, aunt, uncle, brother, sister, brother-in-law, sister-in-law, niece, nephew, first, second, third or fourth cousin, or step-parent

Fictive Kin: any person or persons who, to the biological parents of the child at issue, has an emotional tie to that parent wherein they are like family

Relative: any person connected with a child by blood, marriage, or adoption

Eligibility and Description: The Oneida Child Placement Agency recruits, licenses, trains, and supports American Indian foster homes, kinship families, and like-kin. The kinship care program supports children who reside in the home of a relative, such as an adult brother or sister, a first cousin, a niece or nephew, aunt or uncle, grandparent, or other relations by blood or marriage. The kinship care program serves families in Brown and Outagamie Counties, offering monthly benefits, short-term financial assistance (when funds are available), and case management, whether court ordered or voluntary. To become a kinship caregiver, the child or the caregiver must be Oneida enrolled and reside in Brown or Outagamie County, and the relative caregiver and all adult household members must pass a background check.

> The foster care program has similar requirements, with a higher level of case management, and offers home visits, training, access to resources, respite care, and ongoing support services. The foster care program serves homes in Brown and Outagamie Counties, and homes within a two-hour radius of these counties.





"Like-Kin" as defined in <u>Wisconsin Act 119</u>: an individual who has a significant emotional relationship with a child or the child's family that is similar to a familial relationship and who has not previously been the child's licensed foster parent. For an Indian child, "like-kin" includes individuals identified by the child's tribe according to tribal tradition, custom or resolution, code or law.

ICW serves families with children who are enrolled or eligible for enrollment from birth to 18 years of age.

Eligibility & Description: YonAhali:yó Community Advocacy program inspires Native people to engage in healthy life choices, promoting total wellness for the next seven generations. The program is available to anyone who can show proof of enrollment or self-identifies as tribally affiliated. YonAhali:yó Community Advocacy offers the following community programs:

> The <u>Gender Based Violence Program</u> assists those living with and experiencing abuse in finding help and safety while prioritizing healing within the family. The program offers legal help, education about different forms of abuse, and group support (Women's Domestic Violence Education Group, Beading Circle, and Book Club).

> The <u>Healthy Relationship Program</u> is a weekly domestic abuse intervention program that utilizes an evidence-based curriculum with a Native focus to help offenders understand the complex cultural, social, and historical dimensions of the many forms of intimate partner violence. > <u>Youth Mentor and Advocate Programs</u> seek to build and foster healing and resilience among youth through teachings of empowerment to



preserve safety and build self-esteem using Tsi?niyukwalihoti' (our ways) as the foundation. Services include mentoring and one-on-one support, group facilitation, referral assistance, goal setting, healthy identity support and personal development, youth leadership development, and 2SLGBTQ+ (Two-Spirit, lesbian, gay, bisexual, transgender, questioning, and other identities) support and group work. The Child and Youth Female Advocate ((920) 490-3894) serves female Native American and descendant youth from 6 to 19 years of age, and the Youth and Young Adult Advocate ((920) 490-3797) serves Native American and descendant youth and young adults from 9 to 25 years of age.

<u>Oneida Prevention Program Taking Responsibility and Initiating Life</u> <u>Skills (T.R.A.I.L.S)</u> provides educational activities to enhance youth participation, self-esteem, positive life choices, and emotional wellbeing, promoting healthy lifestyles and total wellness among youth and community. Services include one-on-one youth services, group facilitation at schools and community centers, culturally based programming and practices, and a youth summer program. The <u>Coordinate Community Response Team</u> is dedicated to addressing domestic violence and sexual violence through a multijurisdictional approach rooted in traditional Native values. Eligibility & Description: The Oneida Nation TANF Program's mission is to promote work and personal responsibility to strengthen Oneida Nation citizens and other enrolled Native American families. The TANF program works together with customers and other community resources to promote program goals in a comprehensive manner while respecting individual dignity, culture, and self-worth. All TANF services are supported by federal grant funds from the Administration for Children and Families Office of Family Assistance. Services are subject to funding availability.

Eligibility: All TANF program components are for families with dependent children, non-custodial parents, and caretakers. To be eligible for benefits, the caregiver or the child must be an enrolled member of the Oneida Nation or an enrolled member of a federally recognized tribe living in Brown or Outagamie County.

Services include the TANF Cash Payment, the TANF Crisis Program, the TANF Diversion Program, and the TANF Summer Youth Program. TANF is based on guidelines set by the federal poverty level income limits. Applicants must complete a TANF application and provide all the required verification for services requested. This is not an entitlement program, and eligibility will need to be determined. All diversion and crisis services require a 10% customer contribution.

Eligibility & Description: The WIOA Job Training Program assists individuals with employment and skills development. The program prepares participants for longterm, full-time employment in the shortest amount of time. WIOA offers a wide range of services to eligible consumers, such as job search assistance, resume and cover letter assistance, job interview preparation, career counseling, General Education Development/High School Equivalency Diploma Program incentives, work experience, and training to upgrade employment skills. WIOA strives to provide resources that help Native Americans address barriers to employment and obtain realistic vocational goals.



WIOA is a 12-month program offered to individuals with low income and those who are unemployed or underemployed. The customer must be enrolled with a federally recognized tribe, Native Alaskan, or Native Hawaiian and must be a resident of one of the following counties: Brown, Outagamie, Kewaunee, Door, Calumet, Sheboygan, Manitowoc, or Winnebago.

Eligibility: Must be unemployed, underemployed, or employed and an enrolled member of Oneida Nation residing in Brown or Outagamie County, or an enrolled Native American of a federally recognized tribe who resides within the Oneida Nation reservation boundaries, with no dependent children.

To be eligible for support services, income must not exceed the federal poverty level or exceed the income guidelines of the program. Services include but are not limited to auto repair, auto insurance, transportation assistance (fuel, transit, bus pass) for new employment or job search, work clothing/shoes, work tools, driver's license reinstatement fees, short-term training education fees, alcohol and other drug abuse assessment, group dynamics driver's safety, internet assistance, and professional facial/neck tattoo removal.

Eligibility & Oneida Child Care Services supports families with low incomes by sharing the cost of childcare. Childcare subsidies or assistance may be available for while caregivers work, conduct employment research, obtain training and education (including for teen parents who are attending high school), participate in counseling services, and in emergencies.
