NICWA works at the Tribal, local, state, and national levels to strengthen the interrelated and interdependent networks and systems that support Native children and families. Our work on behalf of Native children and youth responds to changing needs in Indian Country and the evolving context in the child welfare field and the country.

Drawing on ancestral wisdom, NICWA creates conditions for strong and stable nurturing networks wherever Native children and youth grow up. We support families raising Native children by valuing family integrity and ensuring access to culturally based services. Following the leadership of Tribal Nations and in collaboration with public and private sector partners, we strengthen and nurture community-based solutions and services. At all levels, NICWA upholds and advocates for child welfare practice, policy, and resource allocation that is rooted in cultural identity, equity, and Tribal sovereignty.

NICWA uses proactive, culturally grounded strategies that build Tribal capacity and influence policy at all levels. Through hands-on learning and shared expertise, we support Native-led approaches that keep children safe, supported, and connected to their families and communities. Sponsoring the Protecting Our Children Conference is an important strategy to contribute to NICWA's impact.
