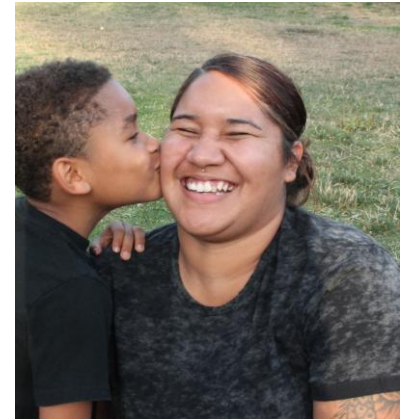


ICWA Quick Resource Guide



The National Indian Child Welfare Association (NICWA) has compiled the following resources to support the work and education of state and tribal child welfare workers and other professionals working with Native children and families in state child welfare systems. These resources are specific to the application of the Indian Child Welfare Act (24 U.S.C. § 1901 et. seq.), which applies in state child custody proceedings involving an Indian child (25 U.S.C. §1903(1), (4)). When a case is under tribal court jurisdiction, the tribe's child welfare code and policies apply.
